**Directors' Reports:**

**Superintendent Report:** Superintendent Tulppo reported that the conversion to Thrun policies has begun. Policies will be shared with the Board. Superintendent Tulppo met with Ironwood, Bessemer, Watersmeet, and Wakefield- Marenisco schools to discuss the grant that was awarded, funding a School Resource Officer for 16 hours/ week in their buildings. GOISD will be the fiduciary for this grant. The State of MI k-12 Budget is anticipated to have increases in per pupil funding, 31n, ISD budgets, Special Education, and GSRP.

**Financial Report:** Budget amendments and contracts were presented to the Board for their approval.

**Grant Report:** Mid-year amendments for grants are complete with the assistance of the business office.

**General Education Report:** Megan Hagen began by thanking everyone involved with the Regional Spelling Bee. It was a huge success. The MTSS Team met on February 2 and discussed capacity vs. district capacity, readiness, and a training plan. 31n continues to grow in all of our districts.

**Career and Technical Education Report:** Ashley Nevins stated that February is CTE Month. As part of our Perkins Grant Application, we will be required to develop strategies and activities to improve proficiency in Reading and Math. The Agriculture Program is going through a rebranding. The name of the program has been changed to Food Systems and Natural Resources. We received another round of grant funding from the Nuts & Bolts Foundation to support our summer camps.

**Special Education Director Report:** Guidance documents are being completed and will be communicated and utilized when complete. The GOISD has postings for SLP, OT, PT, School Psych., and Associate Director of Special Ed. All positions are needed to help alleviate the need for adequate services for students in our districts.

**Special Education Supervisor Report:** Matt Jacques reported that one of our Transition students is currently working at Super One with the Assistance of MI Works. Matt attended an Active Shooter Meeting and shared information with centerbased classroom staff. Three of our center-based classrooms had the opportunity to go snow tubing at Mount Zion. Thank you to staff for planning this event for our students.

**Early Childhood Report:** GSRP recruitment nights will be held March 16<sup>th</sup> at Wakefield-Marenisco and March 17<sup>th</sup> in Ironwood.
